**RULE NO. & TITLE:** 560-X-55-.01. Perinatal Coordinators - Authority and Purpose


**INTENDED ACTION:** Amend 560-X-55-.01.

**Chapter 55. Perinatal ~~Coordinators~~ Regional Directors**

**Rule No. 560-X-55-.01. Authority and Purpose.**

(1) Perinatal ~~coordinators~~ Regional Directors serve as a liaison between the provider community, Medicaid eligible pregnant women and infants, the Department of Public Health and the Alabama Medicaid Agency. ~~These services are provided through a cooperative agreement between Medicaid and the Department of Public Health.~~

(2) The purpose of providing these services is to ensure availability of and access to care for the benefit of Medicaid eligible recipients.
