

270-X-1.07 TRAVEL ALLOWANCES FOR BOARD MEMBERS.

(1) Board members shall be reimbursed for expenses incurred in the course of authorized for in-state travel in accordance with ~~the state expense law~~ and subject to the policies and procedures set by the State of Alabama.

(2) Board members shall be reimbursed for actual expenses incurred in the course of an authorized out-of-state travel, in accordance with and subject to the policies and procedures set by the State of Alabama.
