
INTENDED ACTION: Amend

Chapter 165-X-23 Match Permits

165-X-23-.01 Match Permits
165-X-23-.02 Show Date Requests

165-X-23-.01 Match Permits

1. **Match permits.** Match, contest, and/or exhibition permits will be determined and issued at the discretion of the Commission's executive director upon receipt, review, and approval of all materials required in the Show Date Request.

(a) Matchmaker licensing will be determined at the discretion of the sanctioning Commissions.

165-X-23-.02 Show Date Request/Event Permit

1. **Show dates.** Show dates for any match, contest, or exhibition to be sanctioned by a licensed sanctioning organization shall be submitted by the event promoter in writing to the Commission's executive director no less than thirty (30) days prior to a scheduled event.

Show date notifications shall include:

- (a) Date of the Event
- (b) Location of the Event (full street address and city)
- (c) Promoters Name and contact information
- (d) Promotional Company Name
- (e) Event Status (Professional/Amateur/Pro AM)
- (f) Proposed Licensed Sanctioning Organization or Body (if applicable).

A \$150 Event Permit Fee should be included in the show date request.

2. A match permit fee will be calculated by the Commission. The match permit fee shall be calculated at five percent (5%) of the gross proceeds from ticket sales to the mixed martial arts match, contest, or exhibition, exclusive of any federal taxes.
